**STALLION BREEDING CONTRACT
SHIPPED/PICKED UP SEMEN**

This CONTRACT for the breeding season of 2012, made and entered onto on (date): _____ is by MG Partners, hereinafter designated as Stallion Owner, and _____, hereinafter designated Mare Owner.

This contract shall be for the mare: _____

1. The 2011 breeding fee is \$1500.00 part of which is a non-refundable Booking Fee of \$300.00. The booking fee is due with this contract and the full breeding fee is due at time of shipment or pick up of semen..
2. Mare Owner agrees to pay a Collection/Packaging/Shipping Fee of \$250.00 for each second and additional shipments. Owners or agents who opt to pick up a package from Eastridge Farms will pay the same amount of \$250.00. The mare owner must notify the Stallion Owner of the expected breeding date at least 2 weeks prior to the actual shipping, or pick up date.
3. There is no charge for a disposable shipping container supplied to the mare owner for each shipment of semen, provided the container is returned to The MG Partners Inc.. Actual cost of shipment of semen with container, including the return of the container will be the Mare Owners expense.
4. Mare Owner is responsible for arranging for the diligent insemination of the mare. Insemination must be administered by a licensed veterinarian or authorized technician. Shipped semen must be used only for the mare stated on this contract.
5. Mare Owner is responsible for the pregnancy checking of the mare. If for any reason the mare does not settle, the mare owner will hold the Stallion owner and manager blameless.
6. The Mare Owner agrees to comply with the following: 1) Consult Stallion Manager as to their days of collection. 2) Notify Stallion Manager when the mare comes into heat. 3) Notify Stallion Manager 48 hours before the anticipated time of ovulation. 4) Confirm order for semen before 10:00 a.m. (CST) prior to the day of shipment. Late orders may be denied shipment, or be subject to extra charges. You may cancel the pick up or shipment up until

7 a.m. (CST) on the day of shipment without penalty. Please note that Fresh semen shipments are limited due to availability of stallion during show season. It is advised that you consult with Eastridge Farms prior to submitting this contract for availability of fresh semen.

7. The mare shall be in a healthy and sound breeding condition. The breeding fee is for one pregnancy only.

8. MG Partners Inc. is not responsible for the untimely delivery or condition of the “cooled shipped semen” as we have no control of the shipment after it leaves the custody of Eastridge Farms. The Mare Owner also understands that the mare must be bred immediately, on the same day as semen is received, and proper, accepted methods of handling must be used.

9. This contract contains a “In Foal Guarantee “ If by the end of the Present Breeding Season the Mare has not become and remained pregnant as shown by ultrasound results Certified by a Vetrinarian the purchaser will be entitled to the next breeding season only. The \$250.00 collection fee will apply on all and any rebreeds.

10. If the stallion dies or becomes unfit for service prior to fulfilling this contract, this contract is null and void, and the Mare Owner’s breeding fee will be refunded.

12. Stallion Owner will issue certificate when notification of a live foal, providing all fees have been paid in full.

13. This contract is non-assignable and non-transferable.

14. This Contract represents the entire agreement between parties, No other agreements or promises, verbal, or implied are included unless specifically stated in this written contract.
