**STALLION BREEDING CONTRACT
FROZEN SEMEN**

This CONTRACT for the breeding season of 2012, made and entered onto on (date): _____ is by MG Partners, hereinafter designated as Stallion Owner, and _____, hereinafter designated as the Purchaser. This contract shall be for the stallion Kumano.

This contract shall be for the mare: _____

Breed _____

1. The 2012 breeding fee is \$1500.00 part of which is a non-refundable Booking Fee of \$ 300.00. The booking fee is due with this contract and the full breeding fee is due in advance before MG Partners Inc. approves the shipment of semen by Burwash Equine Services Ltd..

2. This contract includes two insemination doses of frozen semen. Charges for additional dosages required will be at a cost of \$200.00/dose, payable to MG Partners Inc. prior to the request and authorization of shipment of frozen semen by Burwash Equine Services Ltd.

3. This is a live foal guarantee with one return breeding privilege the following season if the mare does not produce a live foal that is capable of standing and nursing. It is understood that any claim for rebreeding must be accompanied by a written statement from a veterinarian within one week of knowing the mare has lost her foal. In the event that the mare dies or becomes infertile, the breeders will be allowed to substitute another mare for breeding the following season.

3. Frozen semen of the Stallion is stored with Burwash Equine Services Ltd. and shipped directly from Burwash Equine Services upon the request and authorization of MG Partners Inc. Burwash Equine Services Ltd. will ship the frozen semen in a dry vapor shipper. Prior to shipment a deposit of \$500.00 or credit card authorization is required to cover the shipping charges. The charges for shipping and handling will include a \$250.00 deposit for the vapor shipper, a charge for filling the vapor shipper of \$55.00 - \$60.00, a rental fee for the vapor shipper of \$25.00 per day, and the cost of couriers, buses, airlines, etc. These charges will apply to the initial shipment of the 2 doses of semen included in the stallion fee as well as any additional shipments required. No semen will be shipped without adequate funds on deposit or credit card authorization to cover expenses. Any balance on deposit will be refunded as soon as MG Partners Inc. is notified that no more semen will be required..

4. The Purchaser is responsible for arranging for the insemination of the mare. Insemination must be administered by a licensed veterinarian or authorized technician.
5. The Purchaser is responsible for the pregnancy checking of the mare. If for any reason the mare does not settle, the Purchaser will hold the Stallion owner and manager blameless.
6. All requests for shipment of semen must be directed to MG Partners Inc. Burwash Equine Services will not make any shipments without the prior written authorization of MG Partners Inc..
7. The mare shall be in a healthy and sound breeding condition. The breeding fee is for one pregnancy only. Shipped semen must be used only for the mare stated on this contract.
8. MG Partners Inc. and Burwash Equine Services Ltd. is not responsible for the untimely delivery or condition of the "frozen shipped semen" as we have no control of the shipment after it leaves the custody of Burwash Equine Services. The Purchaser also understands that accepted protocol for handling and storage of frozen semen must be used.
9. If the stallion dies or becomes unfit for service prior to fulfilling this contract, this contract is null and void, and the Mare Owner's breeding fee will be refunded.
12. Stallion Owner will issue a Breeders certificate when receiving written notification of a live foal, providing all fees have been paid in full.
13. This contract is non-assignable and non-transferable.
14. This Contract represents the entire agreement between parties, No other agreements or promises, verbal, or implied are included unless specifically stated in this written contract.
